NOTICE IS HEREBY GIVEN that the following items will be considered by the Contra Costa Local Agency Formation Commission at its meeting on Wednesday, April 9, 2008 at 1:30 p.m. in the Board of Supervisors Chambers, 651 Pine Street, Martinez, CA.

PROPOSED BOUNDARY CHANGES

LAFCO 07-16 – Delta Diablo Sanitation District Sphere of Influence (SOI) Amendment (Mirant): proposed expansion of the District’s SOI to include 1,427± acres generally located north of Willow Pass Road and south of Suisin Bay and includes the Mirant Power Plant and surrounding properties.

LAFCO 07-22 – Sphere of Influence (SOI) Amendments to Delta Diablo Sanitation District (DDSD) and Contra Costa Water District (CCWD) (Sky Ranch II): proposed expansions to the SOIs for both DDSD and CCWD to include 160 acres+ generally located at the terminus of Ventura Drive, south of the existing Highlands Ranch subdivision and approximately one mile southwest of the Somersville Road/Buchanan Road intersection in the unincorporated Pittsburg area.

LAFCO 08-02 – Walton Annexation to the City of Concord: proposed annexation of 0.45± acres located at 5137 Laurel Drive in the unincorporated Concord area.

LAFCO 08-03 – Annexation 166 to Central Contra Costa Sanitary District: proposed annexation of 88± acres located in six separate annexation areas in Lafayette, Martinez and Orinda.

LAFCO 08-04 – Annexation 313 (Nove) to West County Wastewater District: proposed annexation of 30± acres located at the southeast corner of Pittsburg Avenue and Richmond parkway, in the unincorporated North Richmond area. The purpose of the annexation is to extend sewer services to the property.

LAFCO 08-08 – East Contra Costa Irrigation District Sphere of Influence (SOI) Amendment (Dutra and Adjoining Properties): proposed expansion of the District’s SOI to include 603.31± acres located generally south and east of the intersection of Walnut Boulevard and Marsh Creek Road.

LAFCO 08-11 – Delta Diablo Sanitation District Sphere of Influence (SOI) Amendment (1875 Loveridge Road): proposed expansion of the District’s SOI to include 2.53± acres located at 1875 Loveridge Road in Pittsburg.

LAFCO 08-07 – 4804 Northridge Road Annexation to Mt. View Sanitary District: proposed annexation of 1.44± acres located in the Muir Oaks area of Martinez. The purpose of the annexation is to extend sewer services to the property.
