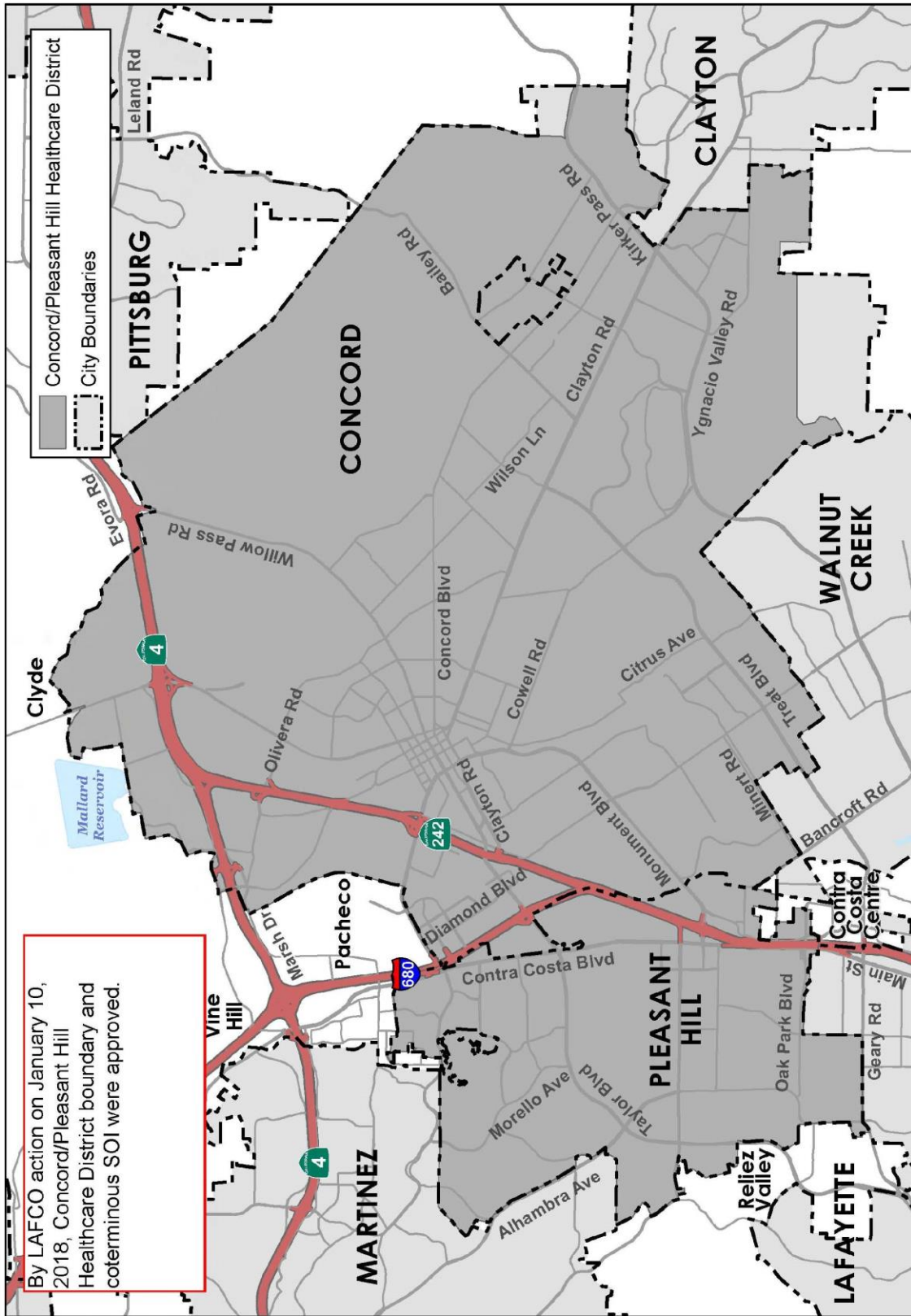

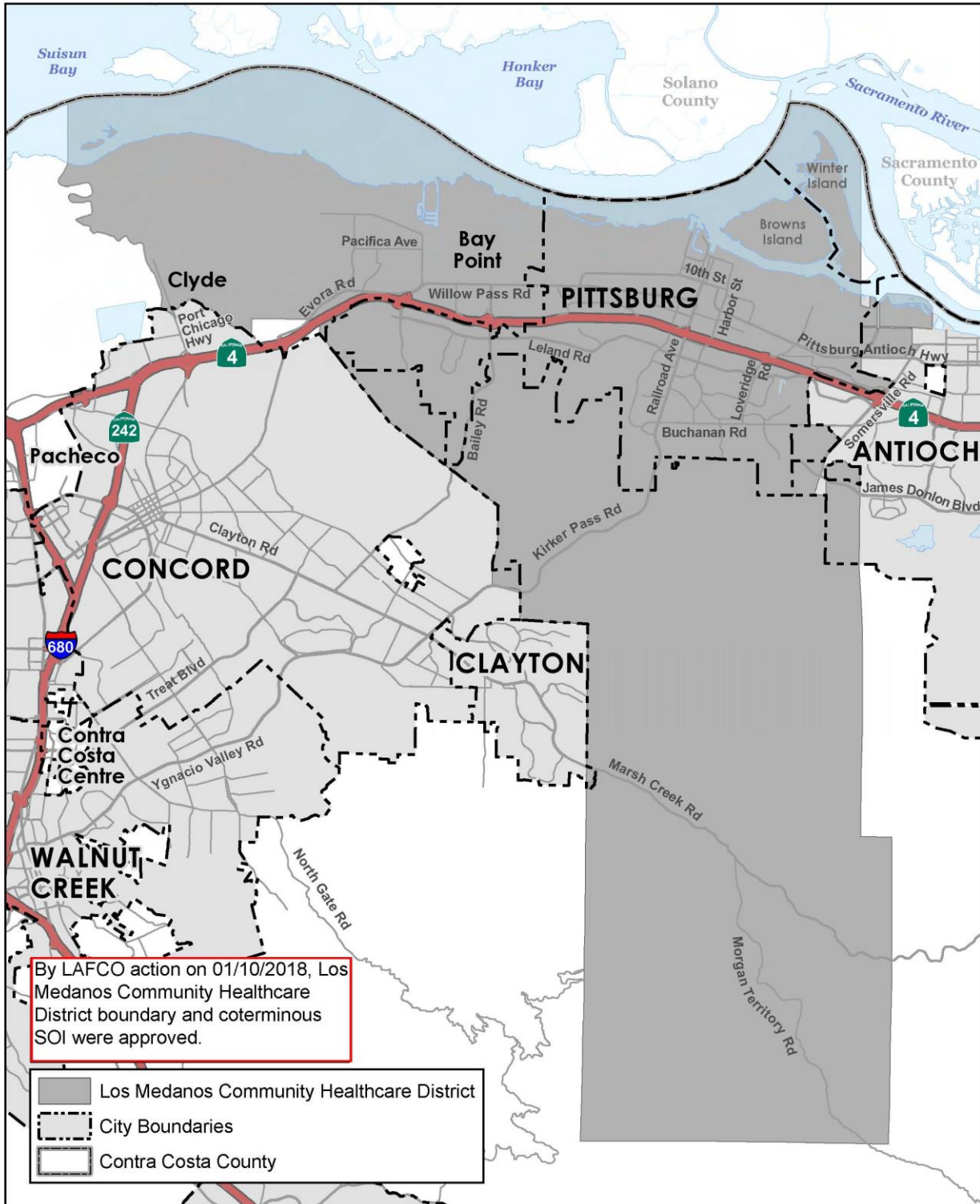

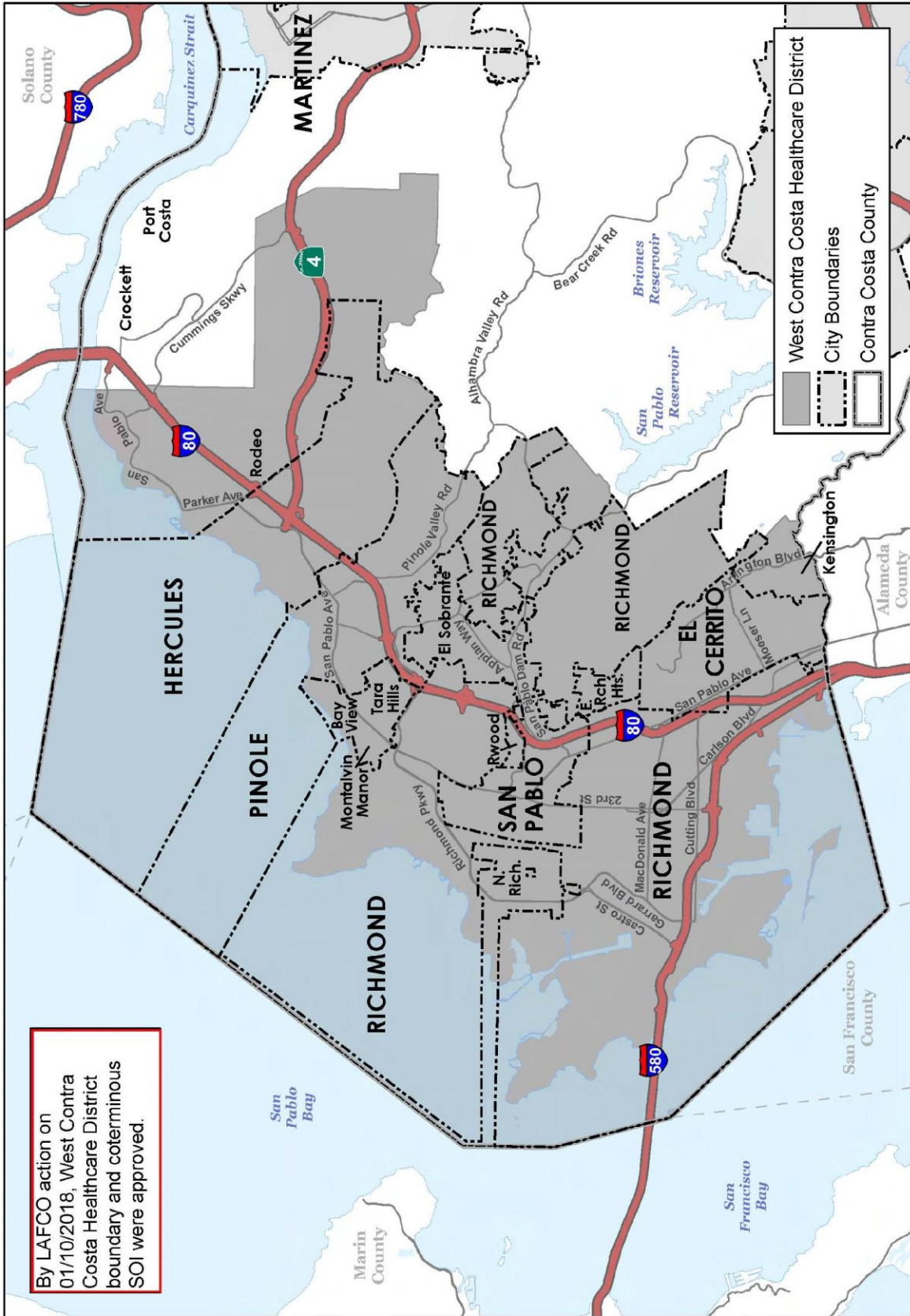

In 2016, the District declared bankruptcy.
