**Expiring Commissioner Terms in 2010**

Dear Members of the Commission:

This is an informational update regarding Commission terms scheduled to expire in 2010.

The Cortese Knox Hertzberg Local Government Reorganization Act of 2000 (CKH Act) includes provisions relating to the composition of LAFCO. In addition, the Commission has its own local policies regarding membership.

The Contra Costa LAFCO is composed of two regular members representing the County, two regular members representing cities, two regular members representing independent special districts, and one regular member representing the general public. Each category on LAFCO also has one alternate member. All terms on LAFCO are four years and expire the first Monday in May.

In accordance with the CKH Act and local policy, appointments for the regular and alternate members are made as follows: for county members by the Board of Supervisors; for city members by the City Selection Committee through the Mayor’s Conference; and for special district members by the Special District Selection Committee through the local chapter of the Special Districts Association. Per the CKH Act, the Commission appoints the public members. Selection of the public members is subject to an affirmative vote of at least one Commissioner from each appointing authority (i.e., county, city, special district).

In May 2010, the terms of four Commissioners will expire: county members Federal Glover and Gayle Uilkema, and special district members Dwight Meadows and George Schmidt (alternate).

LAFCO staff will work with the County and the Special District Selection Committee regarding the upcoming appointments.
