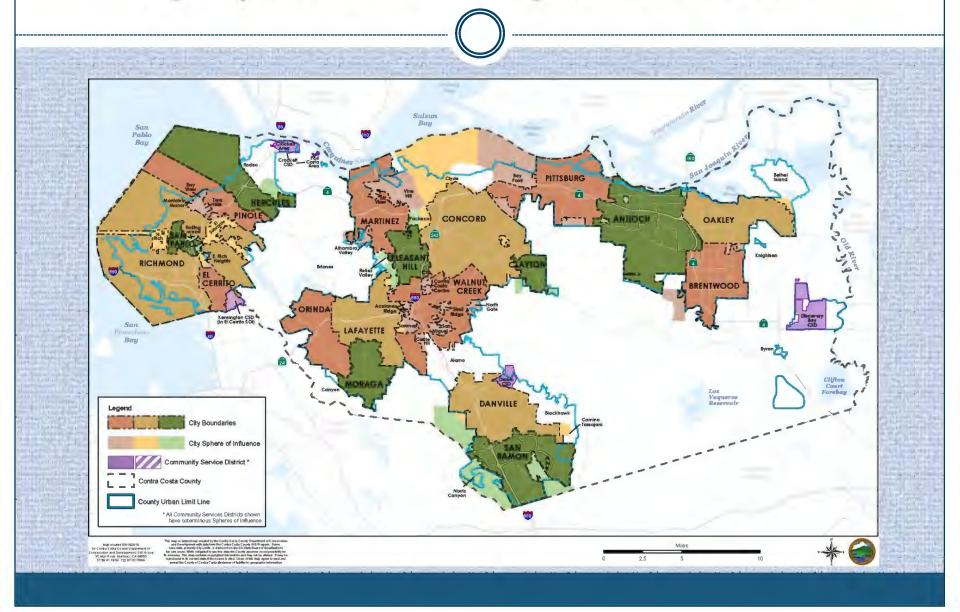

Trends Affecting Contra Costa County

Economy/Jobs/Housing

- 35.5% projected increase in jobs between 2010 and 2040
- 23.7% projected increase in households between 2010 and 2040
- Labor market growth → population growth → housing crisis

Trends Affecting Contra Costa County

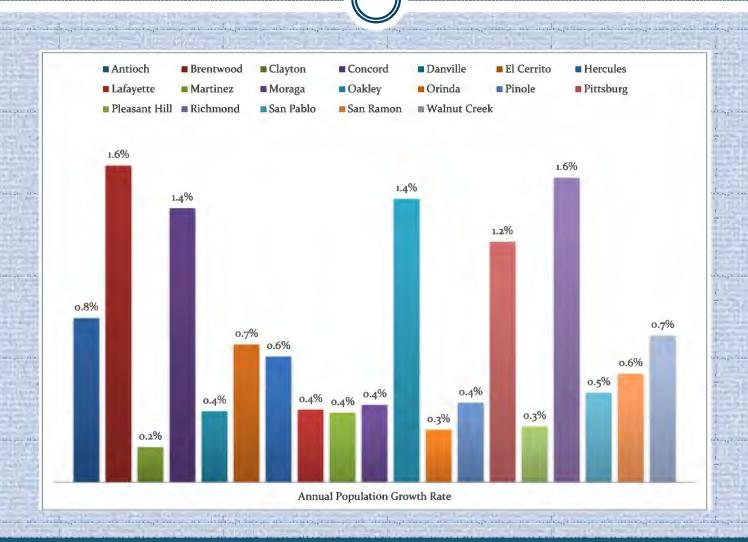
Transportation

- 36.7% of East Bay residents commute outside the area
- Transportation → GHG emissions → climate change

Aging Infrastructure

- City roadways at risk of failing: Martinez
- City roadways below MTC target: Antioch, Concord, Hercules, Moraga, Orinda, Pinole, Pittsburg, Pleasant Hill, Richmond, Walnut Creek

Jobs and Households



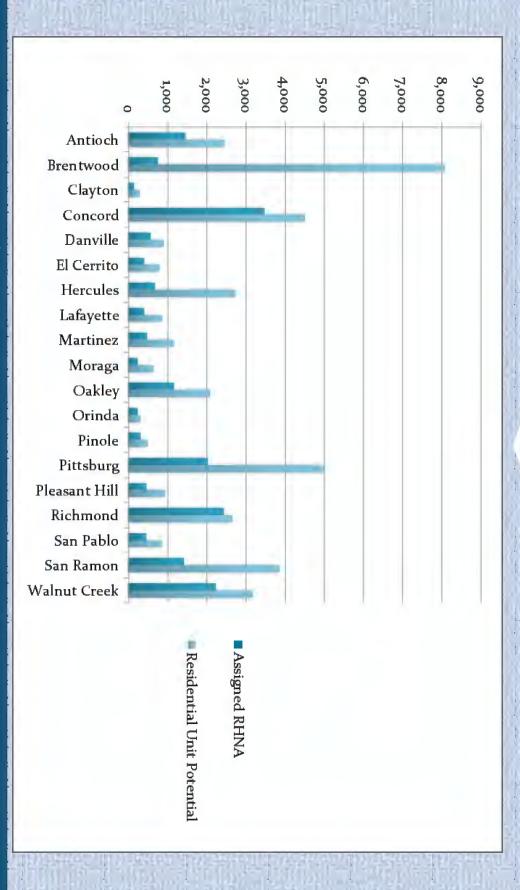
- Employment growth by 2040

Ratio of Jobs to Households



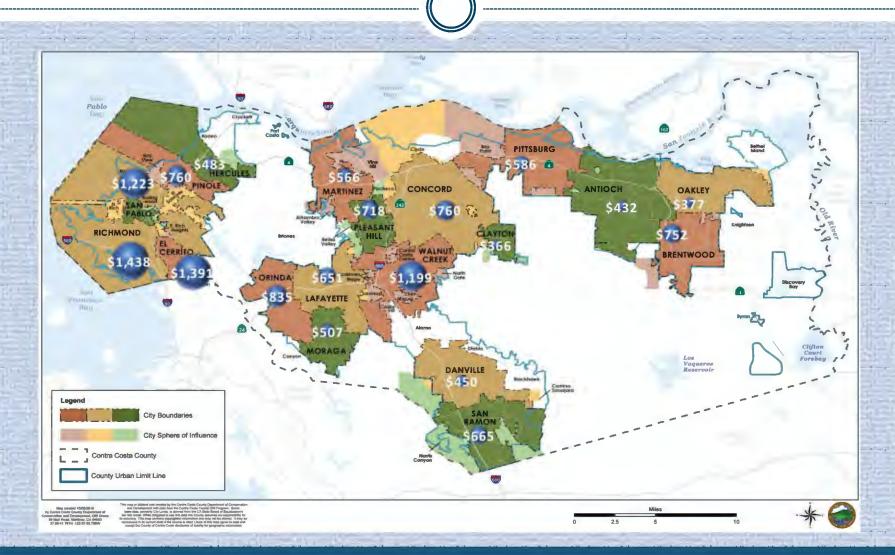
Potential Residential Unit Yield to Meet Assigned RHNA



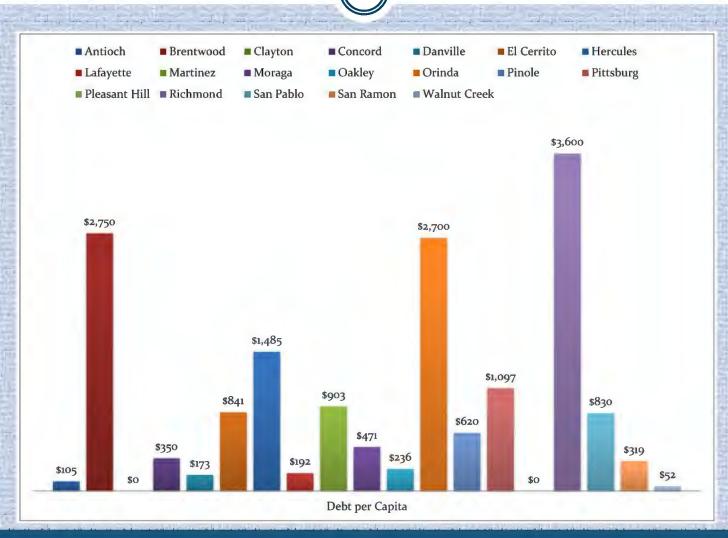
Financial Ability to Provide Services

- Unfunded pension and other-post employment benefit liabilities

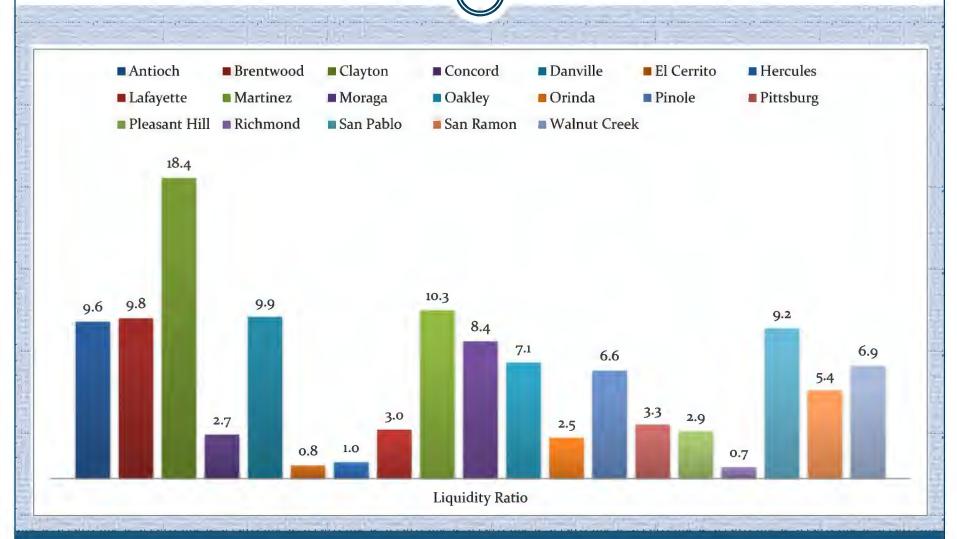
General Fund Expenditures per Capita

Present and planned land uses

The cities and CSDs reviewed in this MSR Update plan for a variety of urban land uses within their boundaries, representing a continuation of the current mix of uses.

Present and planned land uses are adequate for existing residents as well as future growth, as demonstrated in the General Plans.

Present and probable need for public facilities and services

There are no anticipated changes in the type of public services and facilities required within the SOIs for cities and CSDs reviewed in this MSR Update.

The level of demand for these services and facilities, however, will increase commensurate with anticipated population growth over the next five years.

Present and probable future capacity for public facilities and services

The present capacity of public facilities for the cities and CSDs reviewed in this MSR Update appears adequate. These agencies anticipate they will continue to have adequate capacity during the next five years.

Existence of any social or economic communities of interest

In general, communities of interest within the municipal boundaries of each city are included within their respective SOIs.

Contra Costa LAFCO has identified specific social or economic communities of interest relevant to Danville, Lafayette, Pleasant Hill, San Pablo, and Walnut Creek.

Present and probable need for public facilities or services related to sewers, municipal and industrial water, or structural fire protection of any disadvantaged communities within the existing SOI
