Activation of Latent Powers – Kensington Police Protection and Community Services District

Dear Commissioners:

BACKGROUND: Community Services Districts (CSDs) are independent special districts formed and governed pursuant to Government Code (GC) §61000 et seq. CSDs can provide a range of municipal services pursuant to CSD statutes. CSDs are independent special districts typically governed by a five member Board of Directors.

CSDs can provide a multitude of municipal services specified in GC §61100, including, but not limited to, water, wastewater, solid waste, fire protection, recreation, streetlighting and landscaping, abatement, vector control, police protection, library services, maintenance of streets, roads, rights-of-way, culverts, drains, curbs, gutters, sidewalks, transportation, graffiti abatement, flood protection, community centers, libraries, theatres, child care facilities, animal control, pest abatement, cemetery services, and various other municipal services.

A CSD wishing to exercise latent powers in order to provide new or different services must apply to and receive LAFCO approval before providing the service(s). The LAFCO application must be submitted by the legislative body of the subject district, which in this case is the *Kensington Police Protection and Community Services District* (KPPCSD).

The requirements for exercising a new or different service by special districts, and for the LAFCO proceedings, are specified in GC §§56824.10 – 56824.14. In accordance with these provisions, the CSD submitted an application to LAFCO along with a *Fiscal Analysis* (Attachment 1) and *Plan for Services* (Attachment 2) that describes how the services will be provided, along with estimated costs and possible sources of revenues to provide the new services.

DISCUSSION: The Kensington community is an unincorporated town within Contra Costa County. The Kensington Police Protection and Community Services District (KPPCSD) was formed in 1946. It was initially named the Kensington Police Protection District and was reorganized under the CSD law in 1953. The name was changed to KPPCSD in 1995. The KPPCSD currently provides local law enforcement, parks and recreation, and solid waste collection to the Kensington community. The District's sphere of influence (SOI) is coterminous with its service boundary as shown on the attached map (Exhibit A). The KPPCSD encompasses $0.97\pm$ square miles and serves a population of approximately 5,428.

The Kensington Fire Protection District (KFPD) was formed in 1937 and currently provides fire prevention and suppression and emergency medical services. The KFPD encompasses approximately 0.96+ square miles with a population of approximately 5,428.

Recently, KPPCSD submitted an application to LAFCO to activate latent powers (LAFCO 25-01) to provide fire protection and emergency medical services. Also, the KFPD submitted an application to LAFCO to annex KFPD to KPPCSD and dissolve KFPD (LAFCO 25-02). Both districts adopted substantially similar resolutions in conjunction with the proposed activation of latent powers and annexation of KFPD to KPPCSD and dissolution of KFPD, which requires LAFCO to approve the proposed boundary change pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 ("CKH Act").

In addition to the LAFCO applications, the LAFCO applications also include a *Plan for Services* which includes background information, history of the two districts, justification for proposed activation of latent powers and annexation/dissolution, a proposed transition plan, and a fiscal analysis which both districts accepted. Both districts have discussed and support activation of the latent powers and the proposed reorganization.

Plan for Services/Fiscal Analysis: In response to the community's interest, the districts retained Ridgeline Municipal Strategies ("RMG") to prepare a Plan for Services/Fiscal Analysis which include the following components: Background and Setting, History of the Reorganizing Districts, Proposed Annexation Territory Description, Justification, and Plan and Description of Services. The districts held independent and joint board meetings to discuss the proposed boundary reorganization and the fiscal study and to solicit input from the Kensington Community. The RMG report includes background, history of the reorganizing districts, justification, plan and description of services, fiscal analysis, proposed transition plan, and other components.

In summary, the study concludes the following beneficial results of the reorganization:

- **♣** Administrative economies of scale
- Operational policies and procedures will become consistent with and standardized under one organization
- ♣ Increase in effectiveness and efficiency in delivery of services and administrative functions with shared resources and cost savings achieved through reduced redundancy of certain administrative and support functions in finance, accounting, legal, emergency preparedness and by combining technology infrastructure and other administrative functions and services
- ♣ Annual operating savings projected at \$120,000 to \$290,000 per year (increasing over time)
- ♣ Increase in reserve balance
- ♣ Permanent full-time staff, which would reduce reliance on outside consultants
- Consolidation of the community's tax dollars thereby providing greater funding flexibility

CEQA Compliance: KPPCSD, as Lead Agency, found the proposed activation of latent powers exempt from review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Class 20, section 15320 (change in organization of local agencies).

ALTERNATIVES FOR COMMISSION ACTION: After consideration of this report and any testimony or additional materials that are submitted, the Commission should consider taking one of the following options:

Option 1

- A. Find the proposal to be exempt from CEQA pursuant to CEQA Guidelines Class 20, section 15320 (change in organization of local agencies).
- B. Approve the activation of the latent powers for KPPCSD to provide fire and emergency medical services.
- C. Given there are no protest proceedings in conjunction with the establishment of a new or different function of service, direct staff to complete the proceedings.
- **Option 2** Accept this report and DENY the proposal.
- <u>Option 3</u> If the Commission needs more information, CONTINUE this matter to a future meeting.

Approve Option 1.

RESOLUTION OF THE CONTRA COSTA LOCAL AGENCY FORMATION COMMISSION MAKING DETERMINATIONS AND APPROVING ACTIVATION OF LATENT POWERS OF KENSINGTON POLICE PROTECTION AND COMMUNITY SERVICES DISTRICT (FIRE AND EMERGENCY MEDICAL SERVICES)

WHEREAS, a proposal to activate certain latent powers (fire and emergency services) of the Kensington Police Protection and Community Services District (KPPCSD) was filed with the Executive Officer of the Contra Costa Local Agency Formation Commission; and

WHEREAS, the Executive Officer examined the application and executed her certification in accordance with law, determining and certifying that the filing is sufficient; and

WHEREAS, at the time and in the manner required by law, the Executive Officer gave notice of the Commission's consideration of the proposal; and

WHEREAS, the Executive Officer reviewed available information and prepared a report including her recommendations therein, and the report and related information were presented to and considered by the Commission; and

WHEREAS, at a public hearing held on June 11, 2025, the Commission heard, discussed, and considered all oral and written testimony related to the proposal including, but not limited to, the Executive Officer's report and recommendations, the environmental documents and determinations, spheres of influence, and related factors and information including those contained in GC §56668; and

WHEREAS, the applicant delivered to LAFCO an executed indemnification agreement providing for the applicant to indemnify LAFCO against any expenses arising from any legal actions to challenge the activation of latent powers; and

WHEREAS, the Local Agency Formation Commission determines the proposal to be in the best interest of the affected area and the organization of local governmental agencies within Contra Costa County.


NOW, THEREFORE, the Contra Costa Local Agency Formation Commission DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

1. The Commission is a Responsible Agency under the California Environmental Quality Act (CEQA), and in accordance with CEQA, finds the proposed change of organization is exempt from review under CEQA pursuant to CEQA Guidelines Class 20, section 15320 (change in organization of local agencies).


- 2. The Commission approves the activation of the latent powers of fire and emergency services for the Kensington Police Protection and Community Services District (KPPCSD). The KPPCSD currently provides local law enforcement, parks and recreation, and solid waste collection. The latent powers are conditioned on adequate financing.
- 3. The boundary of the subject area is found to be definite and certain as approved and set forth in Exhibit A, attached hereto and made a part hereof.
- 4. The subject area is inhabited.
- 5. There is no protest proceeding or election in conjunction with this activation of latent powers.



Final FY 2025-26 LAFCO Budget

Dear Members of the Commission:

The Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (CKH Act) establishes a process for preparing and adopting LAFCO's budget. Government Code ("GC") §56381 provides that the Commission shall annually adopt a proposed budget by May 1 and final budget by June 15, following noticed public hearings. This report presents the Final FY 2025-26 budget and work plan.

BUDGET SUMMARY: The final FY 2025-26 budget (attached) includes appropriations totaling \$1,047,614 and reflects an overall increase of approximately 1.2% as compared to the FY 2024-25 budget. The increase is primarily attributable to increases in employee salaries and benefits including retirement benefits. The Final FY 2025-26 budget includes a contingency reserve of \$87,000. Details regarding expenditures and revenues are presented below.

EXPENDITURES: Expenditures are divided into three main categories: *Salaries & Employee Benefits*, *Services & Supplies*, a *Contingency Reserve*, along with future liability funds. A summary of expenditures is provided below.

Salaries & Benefits

The FY 2024-25 staffing level includes one full-time Executive Officer (EO) and one full-time Clerk Analyst (CA). The FY 2025-26 budget retains the current staffing level. LAFCO staff is supplemented with consultants and County services.

The final FY 2025-26 Salaries & Benefits account totals \$494,114, reflecting a 3.4% increase as compared to the FY 2024-25 budget. This is primarily due to increases in employee salaries, group insurance, and workers compensation insurance.

LAFCO is also supported by private and public service providers on an as-needed basis. The County provides fiscal, drafting, mapping/GIS and legal services. LAFCO also currently contracts with private firms for financial auditing, environmental planning, and to assist with Municipal Service Reviews (MSRs) and special studies. The FY 2025-26 budget continues these services as reflected in the *Services & Supplies* accounts.

Services & Supplies

The *Services & Supplies* account includes funding for various services, programs and projects including administrative (e.g., office, insurance, rent, utilities, equipment/systems, training, memberships, etc.), contract services (e.g., assessor, GIS, legal, environmental planning, website, financial audits/GASB reports), and programs/projects (i.e., MSRs, special studies).

The final FY 2025-26 Services & Supplies account totals \$408,500 and reflects a decrease of less than 1% as compared to the current FY 2024-25 budget. LAFCO staff anticipates slight decreases in several accounts including building occupancy, employee travel, planning services, data processing services, and CEQA filings.

Regarding the FY 2024-25 adopted budget compared to year-end estimates, we anticipate minor savings and minor increases in several accounts, with an overall decrease of less than one percent.

Contingency Reserve Fund

Each year, the Commission appropriates funds for unanticipated expenses (i.e., special studies, potential litigation, personnel changes, etc.). The Commission's policy provides that "the annual budget shall include a contingency reserve (i.e., 10% of budget) as determined by the Commission. Funds budgeted in the contingency reserve shall not be used or transferred to any other expense account without prior approval of the Commission." Per the Commission's policy, we budget a contingency fund each year. The FY 2025-26 final budget includes an \$87,000 contingency.

Other Post-Employment Benefits (OPEB)

Since FY 2011-12, LAFCO has included in its budget an annual expense to pre-fund its OPEB liability. The most recent GASB report shows that the plan as a whole was underfunded. The final FY 2025-26 budget includes OPEB funding in the amount of \$30,000.

Pre-funding Retirement Liability (CCCERA)

In FY 2017-18, LAFCO began pre-paying a portion of its unfunded retirement liability to have a better contribution rate. The FY 2025-26 budget includes \$25,000 to fund the OPEB liability and \$30,000 to fund the CCCERA liability.

REVENUES

Revenues consist primarily of apportionments received from the County, cities, and independent special districts with each group paying one-third of the net operating LAFCO budget. The city and district shares are prorated based on general revenues reported to the State Controller. Other revenues include application fees, available year-end fund balance, and miscellaneous revenue (e.g., interest earnings).

Application Charges and Other Revenues

The FY 2025-26 final budget includes \$25,000 in application fees. Application activity has been slow. It is projected that LAFCO will receive approximately \$22,000 in application fees in the current fiscal year. The final FY 2025-26 budget includes an anticipated \$25,000 in application fees based on a multi-year historical average.

Fund Balance

GC §56381(c) provides: "If at the end of the fiscal year, the Commission has funds in excess of what it needs, the Commission may retain those funds and calculate them into the following fiscal year's budget." The FY 2024-25 fund balance will be calculated at year end. Based on the beginning year fund

balance, and projected FY 2025-26 revenues and expenses, it is estimated that the available fund balance will approximately \$800,000.

The LAFCO fund balance, or any portion thereof, can be used to offset the FY 2025-26 revenues, thereby reducing contributions from the funding agencies (County, cities, districts); or placed in a reserve account, separate from the contingency reserve that is appropriated each year. The final FY 2025-26 budget includes \$250,000 in fund balance to offset FY 2025-26 revenues thereby reducing contributions from the local agencies.

Revenues Received from the County, Cities, and Independent Special Districts

After processing fees, available fund balance, and other miscellaneous revenues, the balance of LAFCO's financial support comes from local governmental agencies. Agency contributions represent the most significant LAFCO revenue source.

The CKH Act requires that the net operational costs of LAFCO be apportioned one-third to the County, one-third to the cities, and one-third to the independent special districts. The CKH Act describes how the County Auditor is to make the apportionment and collect the revenues once LAFCO adopts a Final Budget (GC §56381). The city and district allocations are based on revenues reported to the State Controller and vary from year to year.

The overall budget is expected to increase by approximately 1.2%. The proposed use of the available fund balance will offset agency contributions for FY 2025-26. The total amount of revenue from funding agencies required to fund the FY 2025-26 budget is \$772,614, reflecting a 1.2% increase.

LAFCO RESPONSIBILITIES, ACCOMPLISHMENTS & GOALS

The FY 2025-26 budget schedule provides for public hearings and consideration of a Proposed Budget (April 9, 2025) and a Final Budget prior to June 15, 2024. The time between these Commission actions is to allow for review and comment by local agencies, the public, and other interested parties, as well as to gather updated budget information.

In accordance with the work plan and final budget, staff provide a summary of LAFCO responsibilities and accomplishments as follows.

Major LAFCO Responsibilities

LAFCO receives its authority and statutory responsibilities from the CKH Act. Included among LAFCO's major responsibilities are:

- Act on proposals for changes of organization/reorganizations (i.e., annexations/ detachments, out of agency service, incorporations, consolidations/mergers, district formations/ dissolutions, etc.)
- Establish, review, and update spheres of influence (SOIs) for cities and special districts
- Conduct MSRs prior to or in conjunction with establishing or updating SOIs
- Perform special studies relating to services and make recommendations regarding consolidations, mergers, or other governmental changes to improve/enhance services and efficiencies
- Serve as responsible or lead agency for compliance with CEQA
- Serve as the conducting authority to conduct protest hearings for changes of organization/reorganizations
- Provide public information about LAFCO and public noticing of pending LAFCO actions
- Maintain/update a LAFCO website
- Adopt and update written policies and procedures
- Adopt an annual budget

In conclusion, the Commission and LAFCO staff continue to exercise fiscal prudence, recognizing the financial constraints of our funding agencies. Approval of the final budget will enable the Commission to perform its core responsibilities and continue its work on MSRs/SOI updates, processing proposals, legislative activities, policy development, and other projects.

CALAFCO Updates and Legislative Position Letter

Dear Members of the Commission:

CALAFCO is pleased to announce they now have full staffing including a LAFCO Executive Officer, three Deputy Executive Officers, and Legal Counsel (Best Best Krieger). In addition, CALAFCO has several consultants including Pamela Miller - Miller Management & Consulting Group and Jean Hurst, Legislative Consultant. Also, CALAFCO recently posted on their website the Final CALAFCO *Revised Policies and Bylaws* available to members only.

CALAFCO is also developing a six to nine month action plan including immediate and future actions including hiring a new CALAFCO Interim Executive Director, reestablishing CALAFCO U, and conducting focus groups. The action plan also includes future 2025 and 2026 CALAFCO activities.

The 2025 annual CALAFCO conference will be held October 22-24 in San Diego. Additional details are forthcoming.

Regarding legislation, CALAFCO recently reached out to all LAFCOs noting concern regarding SB 777 (Richardson) which is now on the Senate floor. CALAFCO requests letters of concern or opposition unless amended.

SB 777 would require LAFCOs to direct local agencies to assume responsibility for abandoned privately-operated cemeteries. SB 777 could potentially add significant responsibilities to LAFCOs and also provides no direction to LAFCOs as to how to assess which local agency is best suited to assume such responsibility which will likely burden the local agency with additional fiscal and liability risks.

LAFCOs are subject to the *Cortese-Knox-Hertzberg Act Local Government Reorganization Act of 2000* or "CKH Act". In creating this statutory structure, the Legislature delegated the power to LAFCOs to regulate boundaries and services of local government agencies. LAFCOs are statutorily tasked with discouraging urban sprawl, preserving open space and prime agricultural

lands, encouraging the orderly formation and development of local agencies, and ensuring the efficient delivery of government services on the state's behalf.

While we are sympathetic to situations where private cemeteries were abandoned and left vulnerable to vandalism and decay, especially for those family members who are interred, LAFCO staff has concerns regarding SB 777.

Most local governments do not currently provide cemetery services. For a LAFCO to direct an entity to take responsibility for an abandoned private enterprise – especially one that may not have expertise that would lend itself to operating a cemetery – is inconsistent with LAFCOs' statutory role and historic practice. LAFCOs do not force service obligations on local agencies. Instead, LAFCOs engage in a deliberative process that incorporates publicly noticed hearings, engagement of local agencies, and opportunity for public comment.

SB 777 offers no specific direction as to how LAFCO is to proceed under the proposed legislation. Rather, it places the LAFCO in the unenviable position of trying to make an assessment without any guidance as to procedure or priorities from the legislature.

Finally, we are unaware of any adequate funding mechanisms that would accompany the transfer of responsibility for managing an abandoned cemetery and making the challenge of taking on the task even more difficult and less desirable for a local agency. We are concerned that taxpayers of a local agency would be concerned taking on additional fiscal and liability responsibilities of a private enterprise, especially when that enterprise does not serve the public at large.

RECOMMENDATION: 1) Send letter of opposition/concern.

On behalf of the Contra Costa Local Agency Formation Commission (LAFCO), we write to express our concerns regarding SB 777, a measure which would require LAFCOs to direct local agencies to assume responsibility for abandoned privately-operated cemeteries. SB 777 could potentially add significant responsibilities to LAFCOs and also provides no direction to LAFCOs as to how to assess which local agency is best suited to assume such responsibility which will likely burden the local agency with additional fiscal and liability risks.

LAFCOs are subject to the Cortese-Knox-Hertzberg Act Local Government Reorganization Act of 2000 or "CKH Act". In creating this statutory structure, the Legislature delegated the power to LAFCOs to regulate boundaries and services of local government agencies. Current and Potential LAFCO Applications

Dear Members of the Commission:

SUMMARY: This is an informational item describing active and potential LAFCO applications.

DISCUSSION: The Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 gives LAFCOs regulatory and planning duties to coordinate the formation and development of local government agencies and their municipal services. This includes approving and disapproving boundary changes, boundary reorganizations, formations, mergers, consolidations, dissolutions, incorporations, sphere of influence (SOI) amendments, and extension of out of agency services (OAS). Applications involving jurisdictional changes filed by landowners, registered voters, and local agencies are placed on the Commission's agenda as information items before actions are considered by LAFCO at a subsequent meeting (Gov. Code §56857).

There is one proposal awaiting completion, two current applications that are either incomplete and/or awaiting a hearing date, and several potential applications.

Current Applications – Under Review/Pending

- **LAFCO 25-02** Annexation of Kensington Fire Protection District (KFPD) to KPPCSD and dissolution of KFPD − An application was recently filed to annex the Kensington Fire Protection District (KFPD) to KPPCSD and dissolve KFPD.
- LAFCO 16-06 Tassajara Parks Project SOI Amendment (LAFCO 16-07) and Boundary Reorganization (LAFCO 16-06) In 2016, the landowner (Vicky Chang) filed applications to amend the SOIs of Contra Costa County Sanitary District (CCCSD) and EBMUD and annex to both districts (30± acres) to develop 125 single-family homes. The subject area is located east of the City of San Ramon and the Town of Danville. The previous landowner recently sold the property and terminated the LAFCO applications. The new property owner recently contacted LAFCO regarding potential SOI amendments and annexation of the subject property. To date, no new applications have been filed.

EBMUD continues to oppose the project and indicates they will not be the water provider (or have the water supply to serve the project). This is consistent with their resolution passed on June 8, 2021. EBMUD staff notes they had meetings with the prior developer (and one where the County was included) to discuss the project. However, EBMUD staff has consistently reiterated their Board's position. EBMUD staff continue to participate in meetings as needed.

Potential and Other Applications

There are several potential applications that may be submitted to LAFCO in the near future including an annexation to West County Wastewater District, an annexation to Byron Bethany Irrigation District, and annexation to Mt. View Sanitary District. Also, since completion of the 2021 *Park & Recreation Municipal Services Review*, the Commission discussed dissolving County Service Area R-9. The matter has been continued since 2021. In April 2025, the Commission voted to continue the matter to April 8, 2026.

RECOMMENDATION – Informational item – no actions required.
